Major in Environmental Chemistry: The major requires completion of 36 hours of chemistry including 105, 106, 115, 116, 305, 306, 307, 315, 316, 321, 322, 406, 416, 430; Biology 101, 102, 103, 104, 336 or Marine Science 200 (offered through the Marine Environmental Science Consortium at Dauphin Island); Mathematics 171, 251, Physics 251 and Physical Science 110 (offered through the consortium agreement with AUM). Chemistry 104 is highly recommended as preparation for 305, but will not satisfy elective credit for either the major or minor. The total number of hours required for a major Environmental Chemistry is 61.
